- Mike started the meeting with a Thank You for all the help and support with the Children's Trout Rodeo.
- The minutes from the May 15, 2022 were read by the Secretary. A motion was made by Rob Brewer to accept the minutes. Seconded by Keith Lindenmuth. Motion passed, all in favor.
- Treasurer gave his report on the Trout Rodeo

Trout Rodeo - Huge success \$6972.00 profit for the club. Going forward we need less hot dogs and hamburgers and more slushy mix. Thank you letters are being sent out. Fairly flawless event. Worked much better giving out prizes at the end of each time slot. LuAnn suggested a bait station for next year. Approximately 130 fish were caught out of the 600 stocked. Suggestion of stocking earlier was discouraged. Keith who volunteered to camp at A-Dock to keep people away was awakened at 1 AM and again at 3 AM to chase people away. Discuss a fountain or aerator to better acclimate the fish will be discussed over the winter. We also need feedback on what prizes are wanted for age groups. Darryl feels the mass mailing was a success as we had 160 new donators. Still working on LWPOA for something on the monthly dues coupon.

Beginning Balance of \$8,200.00 Income \$15,368.00 Expenses \$9,295.77 ending balance \$14,272.23. Anthony made a motion to accept the Treasurer's report. Jan seconded the motion. Motion passed, all in favor.

- Fish Stocking is in the Fall. Do not need to stock crappy or blue gill. Track what is caught at the tournaments and discuss after tournaments what needs to be stocked. Discussion was held on the weed control on the lake. Mike felt going forward the Lakes Committee will probably have the final word on treatment practices to keep the lake healthy. Amount of dead fish currently is due to post spawn, unseasonable heat wave and motor traffic on the lake. Leaning towards bait to Fawn Lake and small mouth to Big Lake.
- Structure – Kim Lewis was in contact with Randy. There are blocks at the ski slope and at the maintenance shed as well. Scheduled for this Friday at 1 o'clock.
- Debbie Borden made a motion to adjourn. Melissa Lindenmuth seconded the motion. Meeting adjourned at 6:14pm.
