Lisa opened the meeting with the Pledge of Allegiance. Susan introduced guest presenter Dr. Sarah Princiotta who presented a data analysis of the lake health

of Fawn Lake and Lake Wynonah based upon data collected by the Lake Committee over the past 3 years. Lake management should measure lake health based on the following:

- Water Clarity
- Algae abundance
- Water temperature at shallow and bottom lake depths

Both Fawn Lake and Lake Wynonah are healthy at this point in time. Dr. Princiotta recommended that data collection for monitoring be standardized and frequent.

### **OPEN FORUM**

### **Regarding Lakes**

146 - Would chemical addition affect data? Yes, herbicide treatment will impact data. Take data before and after treatment.

2556 - Floating islands beneficial? Can be helpful, but doesn't know specifically.

1471 - After elodea treatment dead fish observed - is treatment responsible? What causes algae bloom? Warm water, increased phosphorus.

2078 - How much do geese impact water quality? Biggest issue would be E. Coli, geese are not a top driver for water quality.

2047 - What is biggest culprit affecting lakes? low oxygenation; track phosphorus and monitor algae to get data first before determining causation 664 - What are guidelines to a healthy lake? no fertilizer on lawns, monitoring septic tanks for leaking, wash equipment before entering lake if used outside of lake.

612 - Barb Still is the best leadership of the Lake Committee.

### **Regarding Other Concerns**

2556 - Security report doesn't list findings from patrol. Should include self-initiated outcomes from KRE.

2617 - Shortfall on budget - Administrative \$26 thousand is 25% kick on budget. Response: There is a profit margin for FSR as management fee. But we are no longer billed for every Ala cart item.

Do we anticipate new security system will reduce security expenses? Need to use system to evaluate expenses.

Is the Dam condition good so far? Seepage is monitored.

1471 - Regarding voting - can someone e-vote and also paper ballot vote? No, must select only one method with one control number per member.

2125 - The budget meeting mentioned \$85 assessment, implemented? Not scheduled yet. May have dues increase allowed.

Extra lots dues increase? Maybe

642 - Special assessment in event of an emergency, reserves aren't spent down so may have push-back from community. Gold Star status may be dinged because of the assessment. Board Goal: get the electronic voting passed. Current dues do not provide operating budget neutral. Need to raise dues because cost of living increases are concern. Cannot bring Reserves into operating budget.

1471 - Going to bring back sticker fees? Yes, cost will be adjusted next year. Currently \$40 for power boat/water craft and \$15 for ATV/golf cart.
