- Security Automation Subgroup Steve Kesselmeyer briefed the open meeting on the 3 companies interested in providing automated security services to LWPOA.

#### **NEW BUSINESS**

- Lisa shared that the LWPOA by-laws need to be amended to allow electronic voting. Attorney Sugarman will draft some language for the BOD to review, edit and approve. A discussion ensued on the pros and cons of electronic voting for the LWPOA.
  - o PRO: Electronic voting avoids the approximate \$14,000 cost of holding a hard copy member vote. The current cost of a single electronic vote cycle is \$299.99, providing a saving of \$13,700.
  - O PRO: Increase LWPOA membership participation in the voting process. Currently, a few hundred members submit hard copy ballots. Electronic voting can be done from any information technology (IT) device, such as, home & office computers and smart phones.
  - o PRO: Hard copy voting will still be available to members without IT devices.
  - o CON: There will need to be cyber security protocols to keep elections secure.
- Electronic voting shall be discussed at the next BOA meeting with Attorney Sugerman.
- Heather informed the BOD of a few member violations.
- The selection of future lifeguards for the LW pool was mentioned. A suggestion was made to use a blind voting system to make future lifeguard selections. The topic was tabled for a future meeting.
- Next Board Meeting February 8, 2024, at 6:00 p.m.
