• Lakes Committee noted that to "slow the flow" of water into Fawn Lake stone rip-wrap could be placed in critical areas; cost would be at least \$15,000; is there funding? There is \$5,000 budgeted this year, which means a plan to distribute stone can be developed and additional funding for stone could be added to next year's budget.

Consider retaining an engineering firm to review the needs of Lake
Wynonah community roads - get quotes for hourly rate from three com-

panies.

• A member planted shrubs along border of LWPOA property and member's property - will have to gift the newly-planted shrubs to LWPOA or remove them. A member wants to purchase lot owned by LWPOA that adjoins member's lot. Purchase cannot be approved.
