The meeting was called to order by the President Mike Borden at 5:16 at A Dock. - The minutes from the April 24th, 2022 were read by the Secretary. A motion was made by Deb Borden to accept the minutes as read. Motion seconded by Walt Dunkling. Motion passed, all in favor.
- Treasurer gave a report on where the club stands prior to the Trout Rodeo and anticipated expenses. Experiment of mass mailing to LW residents. Postage of mass mailing was \$1049.00 which was reimbursed by a generous donor. LWBOD will be contributing \$2000 towards the trout. Currently have \$9.291.77 prior to the Rodeo weekend. Jeff Klingman made a motion to accept the treasurer's report. Anthony Snesavage seconded the motion. Motion passed, all in favor.
- Trout Rodeo
 - > Trout arriving Saturday the 28th at 9AM. \$4,000 worth. 18"+ 250 fish: 12-16 100 fish: 10-11" 400 fish.
 - > Chains for bottom of net were located
 - > Fish cleaning table was located will be set up near the bathroom
 - ➢ Buckets needed − 8 -10 5 gallon. Deb Brewer will see about any extras at the Lodge
 - Donuts Debbie Borden reported Giant will donate some, will look into Boyer's.
 Discussion to agreement we will need 4 dozen minimum. She will see who will donate most or use both stores.
 - ➤ Kim Lewis reported a 20 x 20 tent at Ark was \$109 so going with the 20 x 20 tent at Dewald & Lengle for \$75.00. We will erect tent ourselves. Could not find a slushy machine, they do have a snow cone machine. Darryl found a slushy machine. No one carries digital signs to rent.
 - > Food Mike's neighbor is making pulled chicken trays with warmers. Cook Hamburgers Sunday and keep warm in crockpot with sauce, replenish as needed.

- > No registration, no name tags will get their information at the weigh station
- > Good feedback from mass mailing. Darryl did a very nice job on trout rodeo card.
- > Darryl will get 2 large raffle prizes 1 kid's kayak and 1 bike, both generic gender.
- > Darryl will check if he can run a 50/50 through his other organization's small games of chance license and then check with LW BOD.
- Need to go buy prizes, suggestions of remote control boats, Lego kits, fishing rods.
- Walt and Jan Dunkling graciously emerged from retirement to secure monetary and merchandise donations from local businesses. \$560 in checks and gift cards and 12 businesses or individuals providing items for the raffle or prize tables. They also turned in a list of all the businesses with their contact information for future use.
- > T-shirts are in progress through Mystic Printing. No cost yet
- > Darryl has the microphone for Kim to use.
- > Darry & Mike will do a Sam's Club run for prizes and condiments, etc.
- > Baskets for raffle and Chinese Auction. Deb Brewer, Melissa Lindenmuth, & kids will help.
- > Vending company bringing a vending machine for drinks.
- > Need extension cords. Label them to avoid confusion.
- A Dock rentals trash is our responsibility. Mike handles this, but he's out of town 5/21 weekend and tons of rentals this year. \$75 per rental to the club. Get dumpster key from guard. Mike will throw extra garbage bags in the bottom of the cans. Just take trash to dumpster, maintenance takes care of cleaning the tables. Need to power wash before the trout rodeo. Kim Lewis and Joe Bilski will handle 5/21 AM. The Brewers will do 5/22 AM and Mike will be back Sunday night.
- Darryl mentioned that he is in early discussion regarding getting the club listed on the monthly POA dues coupons for a donation to the club.
- Meeting main meals. June 5th Kim Lewis tentatively signed up to do a fish fry. Darryl & Mike do the November year end meeting.
- Structure, Kim will coordinate as Randy in maintenance must operate the boat.
- Anthony made a motion to adjourn. The motion was seconded by Rob. Meeting adjourned at 6:16pm.
