

Lake Wynonah Property Owners Association Board of Directors Workshop Meeting Minutes Wednesday, November 9, 2022 6:00 p.m.

Welcome and Call to Order

Board President Lisa Laudeman Jones called the meeting to order at 6:03 p.m.

Roll Call

President's Report:

- Lisa Laudeman Jones introduced Jesse Wullenbader, engineer with Schnabel Engineering. Mr. Wullenbader reviewed information regarding the sonar scan of the Lake Wynonah dam (hydrographic survey) and the results of his inspection of the spillway wing wall. There is no need for an emergency repair at this time. His recommended next step is a risk assessment analysis of the dam. Mr. Wullenbader concluded his presentation and exited the meeting.
- Motion by Troy Lipp and Second by Ryan Achenbach to contract Schnabel Engineering to complete a Probable Failure Mode Analysis of the dam. Motion carried by all.
- The 2022 dam report to submit to DEP will be completed by WJP and shared with the Board. Schnabel Engineering could be asked to complete annual dam report moving forward.
- The permit for lowering Lake Wynonah should be granted by DEP by next week. Directors discussed lowering Fawn Lake. Lake-front residents could plan for any maintenance of bulkhead or dock. Motion by Scott Chivinski and Second by Mike Flynn to lower Fawn Lake every five years on years ending with "5" and "0" beginning with 2025. Motion carried by all.

• PAHB1795 was recently passed by the Pennsylvania State Legislature requiring an independent third party to be used for HOA elections and other voting. LWPOA is exempt from this legislation because it was founded

prior to 1995.

• Website update request - Directors need to look at their committee information on the website and make any appropriate suggestions for improvement if needed. The Lodge portion of the website is a good example. Give suggestions to Heather Haspert.

- Mike Flynn provided handout with Finance Committee recommendations regarding LWPOA fee increases. Directors reviewed and discussed the recommendations; no agreement was reached. Directors agreed to continue to individually review the fee increases listed and be prepared to discuss and vote regarding the fees at the December workshop meeting.
